

Summary of Ordinances and Resolutions
January 5, 2023

- **Ordinance No. 178 (22-23)** An Ordinance to abolish the position of Wastewater Operator/Maintenance Technician 105/109 that was created by Ordinance No. 292 (20-21), AS AMENDED; and furthermore, to amend the City of Marietta, Ohio's current Table of Organization to reflect the abolishment of said position; and to repeal Ordinance No. 292 (20-21) in its entirety, and declaring an EMERGENCY.

- **Ordinance No. 179 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a contract on behalf of the City of Marietta, Ohio, with FYDA Freightliner Western Star Zanesville of Zanesville, Ohio, for the lease/purchase of two (2) Freightliner 108SD Dump Trucks and warranties; and for the lease/purchase of two (2) Galion 433U-10 Dump Bodies and accessories sold by Ace Equipment of Zanesville, Ohio, for use by the Public Works Department of the City of Marietta, Ohio, at a total cost not to exceed \$383,560.00 under the auspices of the cooperative purchasing program administered by the Ohio Department of Transportation, pursuant to Ohio Revised Code Section 5513.01(B), and declaring an EMERGENCY.

- **Ordinance No. 180 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a contract with 59 Green, Ltd., doing business as GreenCab of Athens, Ohio, for an On-Demand, After-Hours and Alternative-Hours, Transportation Pilot Program for the City of Marietta, Ohio, in the amount of \$122,496.00 for a six (6) month period from January 6, 2023, through and including July 7, 2023; and appropriating a portion of the American Rescue Plan Act Funds for the Project; and declaring an EMERGENCY.

- **Ordinance No. 181 (22-23)** An Ordinance to amend Section 725.21(a) of the Codified Ordinances of the City of Marietta, Ohio, relating to limitations in the number of operator's licenses to be granted and issued to the operators of taxicab fleets in the City of Marietta, Ohio, and declaring an EMERGENCY.

- **Ordinance No. 182 (22-23)** An Ordinance to amend Section 725.28 of the Codified Ordinances of the City of Marietta, Ohio, to create a Section (c) that will establish the rate of fare to be charged by 59 Green Ltd., doing business as GreenCab, who will be operating an On-Demand, After-Hours and Alternative-Hours, Pilot Transportation Program that will run from January 6, 2023, through and including July 7, 2023, unless extended by further action of the Council of the City of Marietta, Ohio and declaring an EMERGENCY.

- **Resolution No. 67 (22-23)** A Resolution to express the appreciation of the Marietta City Council to Rodney Scott for his service to the citizens of the City of Marietta, Ohio, as an employee of the City of Marietta.

- **Resolution No. 68 (22-23)** A Resolution to express the appreciation of the Marietta City Council to Dennis Fisher for his service to the citizens of the City of Marietta, Ohio, as an employee of the City of Marietta.
- **Resolution No. 69 (22-23)** A Resolution to express the appreciation of the Marietta City Council to Bruce Weckbacher for his service to the citizens of the City of Marietta, Ohio, as an employee of the City of Marietta.
- **Resolution No. 70 (22-23)** A Resolution to express the appreciation of the Marietta City Council to Dianna Hively for her service to the citizens of the City of Marietta, Ohio, as an employee of the City of Marietta.
- **Resolution No. 71 (22-23)** A Resolution to express the appreciation of the Marietta City Council to Carol Marshall for her service to the citizens of the City of Marietta, Ohio, as an employee of the City of Marietta.

- **Ordinance No. 183 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids and enter into a contract or contracts for the collection and removal of solid waste and designated recyclable materials from within the City of Marietta, Ohio, and declaring an EMERGENCY.

- **Ordinance No. 184 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into an Agreement on behalf of the City of Marietta, Ohio, with the Washington Soil and Water Conservation District for certain services to be rendered to the City in the administration of its Storm Water Management Program and declaring an EMERGENCY.
- **Ordinance No. 185 (22-23)** An Ordinance to authorize the employment of one (1) additional Firefighter for the City of Marietta, Ohio, for the period from April 1, 2023 through August 31, 2023, and declaring an EMERGENCY.
- **Ordinance No. 186 (22-23)** An Ordinance that the authorizes the City of Marietta, Ohio to pick up the statutorily required contribution to the Ohio Public Employees retirement system for all the employees of the Teamsters Union #637, pursuant to Internal Revenue Code Section 414(h)(2) and declaring an EMERGENCY.
- **Ordinance No. 187 (22-23)** An Ordinance to establish the salaries of certain elected officials of the City of Marietta, Ohio effective January 1, 2024, and declaring an EMERGENCY.
- **Ordinance No. 188 (22-23)** An Ordinance to amend Section 353.11(a)(1) (Impoundment; Immobilization) of the Codified Ordinances of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 189 (22-23)** An Ordinance to amend Section 903.03 (Construction of Streets, Alleys and Storm Sewers) of the Codified Ordinances of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 190 (22-23)** An Ordinance to amend Section 1143.09 (Design Standards) of the Codified Ordinances of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 191 (22-23)** An Ordinance to find and determine that certain parcels of real property owned by the City of Marietta, Ohio, and located along the east bank of the Muskingum River in the City of Marietta, Ohio, known as Lease Area Number 1, being 0.191 Acres; and Lease Area Number 2, being 0.105 Acres, are not needed for any municipal purpose; and to authorize and direct the Director of Public Safety and Service to advertise for bids for the lease thereof; and to further direct that the Director of Public Safety and Service return said bids, with his recommendation for acceptance, to the Marietta City Council within thirty days of the bid opening and declaring an EMERGENCY.
- **Ordinance No. 192 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Ordinance No. 193 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the anticipated purchase of various street construction materials for use by the Public Works Department (formerly the Street Department) of the City of Marietta, Ohio, during the coming construction season, calendar year 2023, and declaring an EMERGENCY.

- **Resolution No. 77 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service of the City of Marietta, Ohio; and the Chief of the Police Department for the City of Marietta, Ohio, to enter into an Exclusive Revocable Joint Use Agreement with the County Commission of Tyler County, West Virginia.
- **Resolution No. 78 (22-23)** A Resolution of support from the Council of the City of Marietta, Ohio, authorizing the Marietta City Community Development Director to submit an application to participate in the Ohio Department of Transportation's Transportation Alternative Program (TAP) grant, for the Start Westward Monument; East Muskingum and Sacra Via Parks Restoration Project – Phase II, and declaring an EMERGENCY.
- **Resolution No. 79 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service of the City of Marietta, Ohio to enter into a Subrecipient Agreement on behalf of the City of Marietta, Ohio with Washington-Morgan Community Action Program for the administration of a Community Development Block Grant COVID (CDBG-CV) Rental/Utility Assistance Program, and declaring an EMERGENCY.
- **Resolution No. 80 (22-23)** A Resolution authorizing the City of Marietta, Ohio to participate in the State of Ohio Cooperative Purchasing Program through the Ohio Department of Administrative Services, Office of Procurement Services, and declaring an EMERGENCY.
- **Resolution No. 81 (22-23)** A Resolution by the Council of the City of Marietta, Ohio authorizing and directing the Director of Public Safety and Service to adopt the most recent Ohio Department of Transportation Pre-Qualified Consultant List for Engineering Services for FHWA Federal Aid Projects, and declaring an EMERGENCY.
