

Summary of Ordinances and Resolutions  
June 1, 2023

- **Ordinance No. 259 (22-23)** An Ordinance to amend Ordinance No. 404 (12-13) and the Exhibit(s) attached thereto that was passed on November 21, 2013; and to amend Ordinance No. 145 (20-21), As Amended, and the Exhibit(s) attached thereto, that was passed on December 17, 2000; and to amend Ordinance No. 330 (20-21), and the Exhibit(s) attached thereto, that was passed on December 31, 2021, in order to provide uniformity, specifically as it pertains to the fringe benefits for the position of the Code Enforcement Officer of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 272 (22-23)** An Ordinance by Director of Public Safety and Service of the City of Marietta, Ohio, authorizing the Council of the City of Marietta, Ohio, referred to as the Local Public Agency (LPA) and/or Legislative Authority, to adopt the following Final Ordinance, for the Installation and Upgrading of Existing Infrastructure for an Interconnected Traffic Signal System at Six (6) Intersections within the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 273 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Ordinance No. 274 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to allocate and/or set aside a portion of monies from the American Rescue Plan Act Fund (ARPA), to be used by the Marietta/Belpre Health Department, in an amount not to exceed \$100,000.00; and declaring an EMERGENCY.
- **Ordinance No. 275 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to allocate and/or set aside a portion of monies from the American Rescue Plan Act Fund, to be used for the Marietta Fiber Optics Project – Phase 2, in an amount not to exceed \$26,000.00; and declaring an EMERGENCY.
- **Resolution No. 101 (22-23)** A Resolution to authorize Sewah Studio’s Inc., an Ohio corporation, to connect a certain premises owned by them, located at 190 Mill Creek Road, Marietta, Ohio, which is outside the corporation limits of the City of Marietta, Ohio, to Marietta City sewer lines, and declaring an EMERGENCY.
- **Resolution No. 104 (22-23)** A Resolution to authorize the Law Director of the City of Marietta, Ohio, or his designee, pursuant to O.R.C. 733.53 to file an appeal of a decision rendered in the Common Pleas Court of Washington County, Ohio in a case styled City of Marietta, Ohio vs. Professional Service Industries, Inc. et al, and declaring an EMERGENCY.

- **Ordinance No. 277 (22-23)** An Ordinance to amend Title Five – Land Development Chapter 1151 of the Codified Ordinances of the City of Marietta, Ohio, pertaining to the General Provisions of Chapter 1151.

- **Ordinance No. 282 (22-23)** An Ordinance to amend Title Five – Land Development Chapter 1156 of the Codified Ordinances of the City of Marietta, Ohio, pertaining to Water Quality Regulations.
- **Ordinance No. 283 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a contract on behalf of the City of Marietta, Ohio, with Strand Associates, Inc. of Columbus, Ohio, to provide professional services related to the Marietta Lead Service Line Investigations, Design and Construction Project, in an amount not to exceed \$100,000.00, and declaring an EMERGENCY.
- **Ordinance No. 284 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a contract on behalf of the City of Marietta, Ohio, with F. H. Paschen, S.N. Nielsen & Associates, LLC, of Batavia, Ohio, to provide construction services related to the Marietta Lead Service Line Investigations, Design and Construction Project, in an amount not to exceed \$300,000.00, and declaring an EMERGENCY.
- **Ordinance No. 285 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Contractual Agreement with Hazen and Sawyer of Cincinnati, Ohio, based upon the quality based selection process, for Consulting Services in connection with the Duck Creek Interceptor Renewal Project at a cost not to exceed \$156,275.00 and declaring an EMERGENCY.
- **Ordinance No. 286 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the Seventh and Putnam Street Improvement Project and declaring an EMERGENCY.
- **Ordinance No. 287 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Contractual Agreement with CT Consultants of Columbus, Ohio, based upon the quality based selection process, for Consulting Services in connection with the Marietta Stream Bank Stabilization Project, at a cost not to exceed \$100,000.00 and declaring an EMERGENCY.

- **Ordinance No. 288 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Community Housing Impact & Preservation Program Partner (CHIP) Agreement on behalf of the City of Marietta, Ohio, with the Washington County Commissioners; and the City of Belpre; and declaring an EMERGENCY.
- **Resolution No. 103 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service to enter into a Preliminary Legislative agreement with State of Ohio, Department of Transportation, on behalf of the City of Marietta, Ohio, (LPA), for the State Route 26 Resurfacing Project in the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 106 (22-23)** A Resolution for the City of Marietta, Ohio, to accept a donation of seven (7) One Hundred Dollar (\$100.00) Lowes gift cards from Thomas F. Havens and his mother, Sally Havens, with said gift cards to be used by the Cemetery Department for upkeep of the cemeteries in Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 107 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service to apply, accept, and enter into an agreement, on behalf of the City of Marietta, Ohio, with the Ohio Environmental Protection Agency for a Planning Loan for the Colegate Drive I/I Improvements Project, in an amount not to exceed \$125,000.00, (Infrastructure Improvements) and declaring an EMERGENCY.
