

Summary of Ordinances and Resolutions Adopted by the Marietta City Council  
November 2, 2023

- **Ordinance No. 337 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the Fire Training Center Project, and declaring an EMERGENCY.
- **Ordinance No. 338 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to enter into a Contract with Smith's Stylecrete and Construction, LLC, of Marietta, Ohio, for the 7<sup>th</sup> & Putnam Street Upgrade (Pocket Park) Project, in an amount not to exceed \$171,184.00, and declaring an EMERGENCY.
- **Ordinance No. 339 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Ordinance No. 340 (22-23)** An Ordinance to establish a plan for the allocation of indirect costs incurred by the Water Revenue Fund, the Sanitary Sewer Fund, the Street Maintenance and Repair Fund, the Fire Department Levy Fund, and the Capital Improvement Fund, to the General Fund of the City of Marietta, Ohio; to provide for the expiration of this Ordinance on December 31, 2023; and declaring an EMERGENCY.
- **Ordinance No. 341 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to transfer the sum of \$92,852.00 for the calendar year 2023, from the Capital Improvement Fund to the General Fund, for reimbursement for calendar year 2023, in respect to the indirect cost allocation provisions established by Ordinance No. 340 (22-23), and declaring an EMERGENCY.
- **Ordinance No. 342 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to transfer the sum of \$369,726.00 for the calendar year 2023, from the Streets Department Fund to the General Fund, for reimbursement for calendar year 2023, in respect to the indirect cost allocation provisions established by Ordinance No. 340 (22-23), and declaring an EMERGENCY.
- **Ordinance No. 343 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to transfer the sum of \$52,858.00 for the calendar year 2023, from the Fire Levy Fund to the General Fund, for reimbursement for calendar year 2023, in respect to the indirect cost allocation provisions established by Ordinance No. 340 (22-23), and declaring an EMERGENCY.
- **Ordinance No. 344 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to transfer the sum of \$340,988.00 for the calendar year 2023, from the Water Department Fund to the General Fund, for reimbursement for calendar year 2023, in respect to the indirect cost allocation provisions established by Ordinance No. 340 (22-23), and declaring an EMERGENCY.
- **Ordinance No. 345 (22-23)** An Ordinance to authorize and direct the Auditor of the City of Marietta, Ohio, to transfer the sum of \$303,403.00 for the calendar year 2023, from the Sewer Department Fund to the General Fund, for reimbursement for calendar year 2023, in respect to the indirect cost allocation provisions established by Ordinance No. 340 (22-23), and declaring an EMERGENCY.

- **Ordinance No. 347 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Ordinance No. 348 (22-23)** An Ordinance to amend Chapter 143 of the Codified Ordinances of the City of Marietta, Ohio, Titled Development Administrator and declaring an EMERGENCY.
- **Ordinance No. 349 (22-23)** An Ordinance to establish the Salary Schedule of the City of Marietta, Ohio, as it pertains to the position of the Community Development Director, and declaring an EMERGENCY.
- **Ordinance No. 350 (22-23)** An Ordinance to amend Section 3 of Ordinance No. 220 (22-23), passed on March 16, 2023, concerning temporary seasonal laborer positions in the Public Works Department of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 126 (22-23)** A Resolution by the Council of the City of Marietta, Ohio for the City of Marietta, a Municipal Corporation, organized under the laws of the State of Ohio, to accept the conveyance of the Marietta Municipal Court Building located at 259 Butler Street, Marietta, Ohio from the Marietta Municipal Court to the City of Marietta, Ohio.
- **Resolution No. 129 (22-23)** A Resolution to authorize Jonathan Castin and Michelle Rene Castin, on behalf of Claire’s RV Camping, LLC, an Ohio limited liability company, to connect certain premises owned by Claire’s RV Camping, LLC, located at 45 Starlite Drive, Marietta, Ohio, which is outside the corporation limits of the City of Marietta, Ohio, to Marietta City sewer lines.
- **Resolution No. 130 (22-23)** A Resolution to authorize Michael A. Shultz and Lori A. Shultz, husband and wife, to connect certain premises located at 975 B. F. Goodrich Road, Marietta, Ohio, which is outside the corporation limits of the City of Marietta, Ohio, to Marietta City water lines, and declaring an EMERGENCY.
- **Resolution No. 131 (22-23)** A Resolution to authorize and direct the Auditor of the City of Marietta, Ohio to establish and designate the “Fire Retention Incentive – ARPA Fund” as a fund for the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 132 (22-23)** A Resolution to amend Resolution No. 87 (22-23) that was passed on March 16, 2023, in order to correct the language used in said Resolution No. 87 (22-23) and declaring an EMERGENCY.
- **Resolution No. 133 (22-23)** A Resolution to authorize Jonathan Castin and Michelle Rene Castin, on behalf of Claire’s RV Camping, LLC, an Ohio limited liability company, to connect certain premises owned by Claire’s RV Camping, LLC, located at 45 Starlite Drive, Marietta, Ohio, which is outside the corporation limits of the City of Marietta, Ohio, to Marietta City water lines, and declaring an EMERGENCY.
- **Resolution No. 134 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service to apply for, accept, and enter into a Cooperative Agreement for a design loan on behalf of the City of Marietta, Ohio, for the Duck Creek Lift Station and Force Main Project with the Ohio Water Development Authority (OWDA) and declaring an EMERGENCY.

- **Resolution No. 135 (22-23)** A Resolution to authorize James Vuksic and Sara Kroll, on behalf of Blizzard LLC, an Ohio limited liability company, to connect certain premises owned by Blizzard LLC, located at 27834 State Route 7, Marietta, Ohio, which is outside the corporation limits of the City of Marietta, Ohio, to Marietta City water lines, and declaring an EMERGENCY.
- **Resolution No. 136 (22-23)** A Resolution to authorize and direct the Director of Public Safety and Service to apply for, accept, and enter into a Loan Agreement on behalf of the City of Marietta, Ohio, with the Ohio Environmental Protection Agency (EPA) through its Division of Environmental and Financial Assistance (DEFA) Water Pollution Control Fund, administered through the Ohio Water Development Authority (OWDA), for a Division of Surface Water (D.S.W.) Regionalization Evaluation/Survey in an amount not to exceed \$50,000.00, and declaring an EMERGENCY.

- **Ordinance No. 351 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the lease of Room 15 (228 sq. ft.) located in the Marietta Area Community Center at the Armory, situated at 241 Front Street, Marietta, Ohio, and to further direct that the Director of Public Safety and Service return said bids with his recommendation for acceptance to the Council of the City of Marietta, within fifteen (15) days of the bid opening, and declaring an EMERGENCY.
- **Ordinance No. 352 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the lease of Room 16 (285 sq. ft.) located in the Marietta Area Community Center at the Armory, situated at 241 Front Street, Marietta, Ohio, and to further direct that the Director of Public Safety and Service return said bids with his recommendation for acceptance to the Council of the City of Marietta, within fifteen (15) days of the bid opening, and declaring an EMERGENCY.
- **Ordinance No. 353 (22-23)** An Ordinance to appropriate and/or transfer funds.
- **Ordinance No. 355 (22-23)** An Ordinance to authorize and direct the Director of Public Safety and Service to advertise for bids for the trimming and removal of certain trees in the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Ordinance No. 357 (22-23)** An Ordinance to amend Ordinance No. 203 (22-23), that was passed on February 2, 2023, by the Council of the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 137 (22-23)** A Resolution to authorize and direct the Auditor of the City of Marietta, Ohio to establish and designate the “First Responder Wellness – ARPA Fund” as a fund for the City of Marietta, Ohio, and declaring an EMERGENCY.
- **Resolution No. 138 (22-23)** A Resolution to authorize and direct the Auditor of the City of Marietta, Ohio to establish and designate the “Marietta Enhanced Pretrial Services Fund” as a fund for the City of Marietta, Ohio, and declaring an EMERGENCY.
